Rain Barrel Workshop: Is scheduled for September 21, 2014 commencing at 1 pm to be held at the Pequest Trout Hatchery. A total of 33 barrels were picked up from Coke A Cola. There is enough hardware to complete 28 barrels. A local farmer has requested the remaining 5 barrels for her greenhouses. Community Garden: The Green Team will investigate this action further.

Electronic Collection Event: Mrs. Fascenelli advised this event is scheduled for Saturday, September 27, 2014 at the Department of Public Works Garage (1710 Route 57). Large rigid plastics will also be accepted at the same time.

Park Beautification: Mrs. Andershonis will email Mr. Tim Terry regarding the possible donation of trees for the park.

Carbon Footprint: Ms. Keggan will continue to input information for this action item.
