It was also suggested that notification be placed on the Township's website along with the above letter so that "Home Based" businesses could also participate.

**<u>Recycling Depot</u>**: Mrs. Fascenelli reviewed the specifications required in order to qualify and obtain points for a recycling depot. The Township may not qualify – but a description and pictures will be available in a month or two.

<u>**Outdoor Furnaces**</u>: Mr. Di Sessa stated that outdoor wood-burning furnaces are denied for zoning at this time. The Planning Board has not been meeting on a regular basis; however they will be discussing outdoor furnaces, solar, and wind turbines. Mr. Di Sessa was not sure if existing units would be grandfathered or not. This would be up to the Township Committee.

**Solar & Wind Power Seminar**: Mr. Di Sessa attended the Solar & Wind Power Seminar at the Warren County Technical School. He advised the seminar was informative and well attended. The seminar addressed how to create ordinances and state statutes. There are currently five (5) Warren County municipalities that have ordinances regarding solar and wind.

**<u>Construction & Demolition Ordinance</u>**: Mr. Jewell supplied a copy of an ordinance from the Township of Mount Olive.

<u>Sustainable Jersey Points</u>: Mr. Di Sessa stated that Sustainable Jersey does not accept submissions one at a time. They require that your combined submission is worth 150 points or more. He will advise at the next meeting the status of what can be submitted.

<u>Mansfield School Science Fair:</u> Mr. Di Sessa said the school science fair may be a good opportunity for the Green Team to promote the activities undertaken by the team.

Next Green Team meeting is scheduled for March 10, 2011 at 7:30 p.m. at the Municipal Building.
