### **PRESENTATION**

Warren County Community College

Dr. Phil Linfante, Board Chair, stated there are 18 community colleges in New Jersey. WCCC has the highest graduation rate of all 18 community colleges and also has dual enrollment with all Warren County high schools. Text books are \$135 for all the educational materials for an entire year. Mid States accreditation evaluated the programs and the college received no recommendations which is unprecedented. WCCC creates new programs all the time, one of which is drone technology.

Chuck Haytaian, retired assemblyman, spoke on behalf of the WCCC. January 28, 1976, he initiated the resolution to create the college with a second by Chris Meyer. The initial wish was for a college without walls by renting space or combining with other community colleges. Over 20,000 people have attended the college. WCCC has one of the best nursing programs in the State. The drone program is one of the up and coming programs. He asked the Committee to recommend the college to the residents.

Mason Dump – Mayor Watters looked at the new mason dump and was impressed with it.

<u>Snow Plow Routes</u> – Mayor Watters stated that Mr. Farino created the snow plow routes. Most of the snow fence is up with the exception of Allen Road/Donaldson's due to ground moisture.

<u>Pheasant Farm</u> – Mr. Hayes reached out to Dave Golden, Director of Fish and Game, regarding the status. He said they have received no submissions for the property or facilities with the exception of the Township's interest in the barn. In 2020 they will remove the pens and some of the older buildings. Mayor Watters spoke with Keri Pflugh's office who said the committee only meets four (4) times a year and, without a quorum, are unable to vote, so it could take a year. Mr. Hayes will email them tomorrow.

<u>Holiday Closings</u> – Mrs. Mora Dillon stated the Township Municipal Building hours need to be voted on for December 24<sup>th</sup> and 31<sup>st</sup>.
