CLERK'S REPORT:

Ms. Hrebenak had nothing to report.

FINANCE REPORT:

Mrs. Mollineaux stated there are resolutions for Cancellation of Unspent Capitol Reserves, Stale Checks, and Emergency Appropriation Road Repair for Hazen and Mitchell Roads due to the damage from the last storm. Another repair that has to be done to Bright Road which will be a big-ticket item, but there is

no firm information on the amount.

Mrs. Mollineaux stated that Mr. Ferry will be at the next meeting to go over the audit report for 2018. It's typically due June 30th, but he's not at fault for the holdup. There is a section where the State requires the actuarial report for the health benefits on how much the town's portion of payment. Since the State hasn't sent that yet, the audits are extended. Mr. Ferry had an Audit exit conference with Mrs. Mollineaux and he was happy with the progress.

EMPLOYEES' REPORTS:

Mrs. Fascenelli stated that she had nothing to report.

ENGINEER'S REPORT:

Mr. Kastrud had been on vacation, so he submitted a limited report. More of his report will be ready in two weeks. The progress on his road inspections with Mr. Snyder is going well.

ROAD DEPARTMENT:

Mr. Farino reported for Mr. Snyder that he was not happy with the tar and chip. Mrs. Mollineaux stated that it was done through the Co-Op which is not a problem, but Mr. Snyder was not happy with the product and he filed a complaint with the Morris County Co-Op which is the process if you're unhappy with the work. Mr. Farino state the stone wasn't triple-washed and wouldn't stick. He also stated that the County roads that had it done looked like they were paved. Mayor Watters asked if the issue will be taken care of this year. Mr. Farino stated they will have to fix it or not pay as much.

Mr. Farino also reported that the sweeper has issues that will try to fix in-house, but will cost thousands of dollars. The backhoe needs brakes. A John Deer quote is \$9,000, so they will try to do it in-house.

Mayor Watters asked about the Municipal Building skylights. Mr. Farino stated he spoke to the contractor who will contact the manufacturer because he installed a faulty piece that was damaged when it was installed and it needs to be replaced.

WHEREAS, the Township Committee further finds and declares that the Department of Public Works, has correctly recommended that the aforementioned road repairs be remedied through the award to the following:

Tilcon and Eastern Industries

WHEREAS, the emergency costs are to be funded through 2019 Capital Reserves account number C-04-44-215-0000-0003 in an amount not to exceed \$10,000.00 and the CFO has certified the availability of funds;

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Mansfield does hereby declare the existence of a public emergency warranting the completion of the road repairs as soon as possible and does hereby award said project to the entities mentioned above.
