AWARD OF CONTRACT FOR AN INTERNATIONAL CAB AND CHASSIS TO NAVISTAR, INC. THROUGH BROWNS HUNTERDON INTERNATIONAL, BLOOMSBURY, N.J. UNDER NJPA 081716-NVS

WHEREAS, the Township of Mansfield is authorized pursuant to N.J.S.A. 52:34-6.2(b)(3) to use alternative procurement methods by entering into nationally recognized cooperative purchasing agreements, provided certain requirement are met; and;

WHEREAS, the Mansfield Public Works Department has recommended the award of a contract for the purchase of a International Cab and Chassis to Browns Hunterdon International based on a proposal dated May 21, 2019, which was submitted in accordance with a bid submitted by Navistar, Inc. to the National Joint Powers Alliance ("NJPA"), a national cooperative; and,

WHEREAS, the NJPA and the contract award by the NJPA to Navistar, Inc. meet the requirements of State law for awarding contracts through national cooperatives, including the following:

- The Navistar, Inc. contract was awarded through a competitive bidding process that complies with the laws covering the issuing entity;
- The NJPA is a contracting unit as defined by statute; and
- The NJPA bid was advertised as a national cooperative contract;

WHEREAS, Navistar, Inc. has submitted required documentation with its proposal, including the following:

- New Jersey Business Registration Certificate;
- Non-Collusion Affidavit and Stockholder Disclosure statement; and
- Proof of EEO compliance;

WHEREAS, as required by State statute, the Mayor and Committee are satisfied, based on the information and representations presented to it, that the use of the NJPA contract shall result in cost savings after all factors have been considered; and,

WHEREAS, as recommended by New Jersey Division of Local Government Services Local Finance Notice 2012-10, the Township published a Notice of Intent to Award a Contract under a National Cooperative Purchasing Agreement establishing a comment period for the award of the contract to Browns Hunterdon International under the NJPA contract; and,

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Committee of the Township of Mansfield, County of Warren and State of New Jersey that the recommendation of the Mansfield Public Works Department be and is hereby approved and that a contract for the purchase of a International Cab and Chassis – be and is hereby awarded to Browns Hunterdon International, in the amount of \$58,401.00 in accordance with their proposal dated May 21, 2019; and,

They'd like to place them this weekend on Saturday. Mr. Snyder commented that they be placed in areas where they cannot sting anyone. Mayor suggested the boxes by the cell towers be placed in the woods or cell workers will kill them.

A discussion regarding grant payment and purchase orders for the bee boxes took place between the Committee and Mrs. Mollineaux, CFO. Mayor Watters suggested holding off putting up the boxes until the payment issue is resolved. Mr. Misertino will tell the Environmental Commission to give Mrs. Mollineaux the necessary paperwork for payment to be made.

Mr. Lavery, Esq. stated that if anyone gets stung by a bee and has an allergic reaction, they would claim it came out of one of our bee boxes.
