### August 12, 2020

This meeting was held in person and on the Zoom platform. The Township Committee and the public were able to remotely hear the meeting audio.

### **CEREMONY**

Officer Michael Citarelli, Officer Thomas Hill, and Detective Michael Camerata were presented the Meritorious Service Award "for accomplishing an act under adverse conditions with some degree of hazard to life and limb to the officer and injury to a third party is prevented". The officers had de-escalated a threatening situation of an aggressive male with a knife on March 2, 2020.

Mayor Watters thanked the officers for the work they do.

### DISCUSSION

Mount Bethel Church – Michael Margulies answered questions about the cemetery wall and fencing. He sent the Committee a memo on August 5<sup>th</sup> that outlined three options for applying for the Municipal and Charitable Grants. He suggested holding off applying this year since it was the lowest total received to be distributed to grant recipients applying for the 2021 grant. They were talking about not giving grants to groups who have already received funding for their current projects.

First option Mr. Margulies suggested was to continue with the grant request and see what happens. Second option was to determine how much money you would take as an absolute minimum this grant round.

Third option, to anticipate that you're not getting a grant this round, and ask if the grant can be tabled until next year and hold our application.

Mr. Margulies feels option three is the best, telling them to hold it until next year. Right now, he suggested moving forward with the State and remaining County money for the designing of the septic and interior. If we get the grant money next year, the project can be finished in 2022. The stoops will be bid out. Mr. Margulies' recommendation is for him to write a letter to the Municipal and Charitable Foundation to hold off for the 2021 round and resubmit the application. He will forward the letter to the committee to review for feedback.

Discussion of the fence took place. The Committee agreed to get estimates for fencing now to see how much it will cost. The next County Meeting will be the 1st Monday in September if any of the Committee wanted to attend virtually.

### PRESENTATION

<u>Internet Provider Planet Networks</u> – Robert Boyle stated that Planet Networks is an internet provider regulated by the New Jersey Board of Public Utilities for aerial construction of high-speed internet and phone. He asked for the consent of the Municipality to grant permission of the right-of-way to allow access to run fiber optic lines on existing telephone poles. New poles are not covered and would be applied for separately. Committee will discuss and will notify Planet Networks of their decision.

### **CLERK'S REPORT**

Ms. Hrebenak and Mr. Farino sat in on the meeting for the Warren County Transportation Plan. They are in the process of redoing the plan that was completed in 1982 They are looking to improve transportation concerning truck traffic, and they want to know if there are any issues in town or barriers to walking or biking. Ms. Hrebenak and Mr. Farino did mention things they were concerned with, but if anyone has any concerns, please let Ms. Hrebenak know and she'll send it to the County. She will also post it on the website so the residents know that there is a Wikimap were they can mark areas of concern. Nothing will be completed until 2021, but they are starting the process.

Mayor Watters stated there is one issue in town, but may not be in connection with the County, where trucks come in with GPS on the back roads and get stuck or break off the sides of bridges, like Snyder Road with 45 ft. tractor trailers. He suggested we speak with Mr. Kastrud to see if Bright Road would qualify for the Transportation grant.

<u>HVAC Evaluation</u> – Ms. Hrebenak will meet with the contractors for the evaluation. Hopefully there will be more information on the evaluation by the next meeting.

<u>Small Business Grant Program</u> – Two programs have opened up with the NJEDA for their small business grant program for the 13 counties that didn't get CARES ACT or COVID funding. If anyone needs that information, contact Ms. Hrebenak. Also, some of that funding will be applied to small landlords. Mrs. Mora Dillon asked that this information be put on the website and in the newsletter, and to let WRNJ know.

<u>DOT Grant/Bright Road</u> – Mayor Watters looked over the State Department of Transportation Grant Application and mentioned to Mr. Lavery that it might fit the bill for the Bright Road project. Mr. Kastrud would have to make application for it. Ms. Hrebenak will speak to Mr. Kastrud about it tomorrow. That road will need a lot of money to fix so it doesn't wash out.

### **EMPLOYEES' REPORTS**

<u>Cleaning Company</u> – Difficulties where the sub-contractor didn't show up again and Mrs. Fascenelli gave the company all the dates where cleaning did not occur. She asked them to adjust the billing. If the sub-contractor doesn't show on Friday, she will contact the company to let them know the sub-contractor is not working out for us.

<u>Monthly Recycling Event</u> – Since PCFA is not accepting our monthly recycling collection, Mrs. Fascenelli spoke to David Deck, Warren County Recycling Coordinator, who suggested writing a letter to the PCFA Board, with a copy to him and the County Freeholders. Mrs. Fascenelli would like more clarification from PCFA as to why this is not a viable option. Mayor Watters asked the Committee's opinion, after discussion, they asked Mrs. Fascenelli to draft a letter for Committee review.

Tax Properties – Mayor Watters stated Mrs. Mollineaux sent him an email for review. In Mrs. Mollineaux's absence, Mrs. Fascenelli explained the small foreclosure list is for the 2020 In Rem that we have the attorney work on and a resolution can be ready for the next meeting. The larger list is the township-owned properties with the exception of the latest 2018 In Rem properties. Mayor Watters asked the Committee if they wish to sell the ones in place now or wait until we get the approvals from the County, add that to the list, and sell them all. Mayor Watters asked how long it would take, Mrs. Fascenelli stated the County had them, it's just a matter of us checking when the deeds are recorded. Mayor Watters suggested they wait and sell them all at one time. Mrs. Fascenelli stated not all the properties would be able to be sold if they are small 25' x 25' lot. Mayor Watters stated if it doesn't have a contiguous owner, tell the County to take them off the tax rolls, but Mrs. Fascenelli stated they are already in the Township name and that's how they would remain. Mayor announced that at the next meeting there will be a resolution for the new ones to be researched and closed on and as soon as the County comes back with the ones that we've just had done, be placed on this list and we'll sell them all with Maxx Spann online. Ms. Hrebenak stated that it may be a good idea to hold onto some of the properties to use for the Township's COAH obligation. Mayor Watters stated that they would need to be within the public water and sewer area.

### **COMMITTEE COMMENTS**

<u>HVAC System</u> – Mayor Watters stated we have a contractor that wants to look more at the system, so we are going to wait for the other companies to look at it and then move forward.

<u>Gramco (microphones)</u> – Mayor Watters stated \$4329 for 7 new microphones in the meeting room is one option; the other option is \$7,000 with a different mixer. Ms. Hrebenak stated our mixer can't expand, so we would need a new mixer to add more mics. The microphones would be needed to have a regular meeting for the Land Use Board. Mr. Farino stated the Land Use Board meetings run smooth, very few people come to the meetings, and members have had no issues yet; he feels it's not necessary now. Both he and Mayor Watters stated they can look into it in the future. Discussion tabled.

<u>Tri-County Grant</u> – Mr. Hayes received a call from Mr. Hague, President of Tri-County Fire, that they received a \$139,000 grant for AirPacks. They are asking for help to offset their initial fee for the grant writer for 10% matching of the grant. Mr. Hayes stated we have \$50,000 set aside in the trust fund for gear and we can take money out of that. This will be discussed in Executive Session.

Mr. Farino stated John Snyder has someone coming in next week to give a quote on the tennis court resurfacing.

<u>Job Application</u> – Mr. Farino asked about pesticide requirement and retirement for the part time position. Ms. Hrebenak stated once you go over a certain threshold, they have to contribute to DCRP. Mr. Farino asked if the employee would get the money back from the pension system when they left Mrs. Fascenelli explained that the Township participates in three different pension systems – police and fire, public employees, and DCRP. DCRP is based on hours in conjunction with the salary. The State is pushing that every employee of a municipality contributes to one of the pension programs and it's a percentage. It's hours and salary combined, it's sometimes by hourly rate, and sometimes it's by salary and how many hours you work. Mrs. Mollineaux would be more equipped to answer that type of question, but we do have to participate in DCRP.
