## AN ORDINANCE AMENDING CHAPTER 281 OF THE TOWNSHIP'S GENERAL ORDINANCES TOWNSHIP'S PROHIBITIONS ON SMOKING TO INCLUDE PROHIBITING SMOKING ON PUBLIC PROPERTY

WHEREAS, the Township Committee of the Township of Mansfield finds that as determined by the New Jersey Legislature, smoking is one of the leading causes of preventable disease and death in the United States. In addition to the deleterious effects upon smokers, tobacco smoke is a substantial health hazard to the public, and an annoyance and a nuisance to the nonsmoking public. Tobacco smoke also creates a substantial health hazard to residents of the Township of Mansfield who may be participating in activities or events on public property; and

**WHEREAS**, while it is not the public policy of the Township to deny anyone the right to smoke, a balance must be struck between the right of smokers to smoke and the right of nonsmokers to breathe clean air. The Township Committee finds that on public property, the right of nonsmokers to breathe clean air outweighs the right of smokers to smoke; and

**WHEREAS**, this prohibition is consistent N.J.S.A. 40:48-1, 40:48-2 and 2C:33-13, which provide that smoking may be prohibited by municipal ordinance in any public place and the New Jersey Smoke-Free Air Act, N.J.S.A. 26:3D-55 et seq., which permits municipal ordinances to impose greater prohibitions against smoking than those provided under the Act, and N.J.S.A. 40:48-1, 40:48-2 and 2C:33-13, which provide that smoking may be prohibited by municipal ordinance in any public place; and

WHEREAS, the Township Committee recognizes the well-known health and safety risks posed by smoking

and finds that it is within the public interest to prohibit smoking on public property, such as recreation areas; and

**WHEREAS**, the Township Committee has determined that the public interest is especially implicated in preventing the youth of Mansfield Township from being exposed and succumbing to the temptations of experimenting with tobacco products; and

**WHEREAS**, the Township Committee also finds that the appearance of the recreation areas can be enhanced and the limited resources of the Township's Department of Public Works can be conserved if smoking were to be controlled in such areas, thereby keeping such areas free of the litter generated by the smoking of cigarettes, such as cigarette butts, ashes and packaging.

**WHEREAS,** smoking is defined as the burning of, inhaling from, exhaling the smoke from or the possession of a lighted cigar, cigarette, pipe, vaping devices, or any other matter or substance which contains tobacco or any matter that can be smoked, or the inhaling or exhaling of smoke; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Mansfield that Chapter 281 of the Township of Mansfield General Ordinances be amended to include the following section:

#### Section 281-2 SMOKING PROHIBITION ON PUBLIC PROPERTY

Smoking shall be prohibited in all public recreation facilities owned or leased by the Township of Mansfield and all property owned or leased by the Township of Mansfield upon which the public is invited or upon which the public is permitted and where individuals gather for recreational activities.

#### Section 2

All other ordinance provisions which are inconsistent with the terms of this Ordinance, are hereby declared null and void and repealed.

Mrs. Mora Dillon made a motion to approve Ordinance 2021-04, which was seconded by Mr. Farino.

Mayor Watters opened the public portion of the meeting; seeing no comment from the public, public portion was closed.
