### **RESOLUTION 2020-180 School Board Election Change**

Mr. McGuinness made a motion to approve Resolution 2020-180 School Board Election change, which was seconded by Mrs. Mora Dillon.

Mayor Watters opened the meeting for public comment.

Laura Baggerly disagreed to move the school's budget voting date to April because it will cost the taxpayers more money and will not increase public participation and input.

Brenda Sams asked for an explanation of the change from November to April and the benefit to the tax payers. Mrs. Mora Dillon stated it would enable the public to vote on the school budget and there would be more taxpayer oversight. Public currently does not vote on the school budget, but will be able to in April.

Kristie Mastrolacasa, 12 Parkview Drive, asked why this change is necessary. Mrs. Mora Dillon had attended one board meeting and questioned a few expenses. The board functions under adequacy and has gotten grants. Wants to know why this is coming up at this time and what budget issues the Committee is concerned with. Mrs. Mora Dillon stated the Committee feels the taxpayers should have a say in the school budget.

Anna Maria Lalevee, 45 Canterbury Lane, state the board is within their budget. Asked if this has ever happened in the past. Mayor Watters explained that years ago the budget was voted on in the primaries that gave the public a better opportunity for budget oversight. When the vote was moved to November, the Mayor stated that the oversight was minimized.

Dr. Anthony Giordano. Superintendent Mansfield Elementary School, stated that in 2009 the governor implemented a 2% cap and moved the vote to November where the budget no longer had to be voted on. Mansfield's school budget has remained within the 2%. If the budget gets voted down, there will be layoffs of personnel and programming. The taxes for Warren Hills are higher than Mansfield.

Mr. Lavery explained the legislature states you can move the election each year from April to November. They also put in a mechanism that if the Township or the school board wanted to change it, they could by passing a resolution. It has to be done 85 days before the third Tuesday in April so it has to be approved and sent to the County Clerk by January 24<sup>th</sup>.

Mrs. Mora Dillon requested the public to look at what is being spent.

Kristie Mastrolascasa, 12 Parkview Drive, stated that when they have their budget hearing, it is made relevant to the public, and the public is welcome to review every line item and ask questions at the budget hearings, but no one comes to those hearings. The budget is voted on after that hearing. She also stated that when the public goes through the budget, it leads to personnel cuts of teachers and paraprofessionals and the kids suffer. The public is welcome to attend the budget hearing.

Dr. Anthony Giordano asked that if the budget gets voted down, and goes in front of the Committee and the Committee makes any cuts, will taxes still go up. Both Mr. Lavery and Mayors Watters said they probably will not go up.

Mark Smith, 528 Mt. Bethel Rd, if the budget is moved to April to be approved, they would not be able to send it to the County and the State in time and would reduce the guality education they provide.

Karen Mele,102 Highview Terrace, stated by moving it to April, less people will vote because more people show up to the November election.

Mayor Watters asked for further comment from the public, seeing none, the public portion was closed.
