Mr. Lavery announced they emerged from Executive Session at 8:08 pm where they discussed:

 was not present which was conducted by Conflict Counsel Robert McBriar, Esq
- Potential DEP lease with the Township which is a contractual matter

No official action was taken. Copies of these minutes will be available at such time the Committee determines there is no longer a harm to the public interest.

CLERK'S REPORT

Ms. Hrebenak stated there is no report at this time.

FINANCE REPORT

Mrs. Mollineaux reported they went over the budget in our last meeting.

There are a couple of items on the agenda:

- Rescinding the resolution done earlier in the year for rock salt and moved the money to a new resolution
- Rescinding another resolution because Maser Consulting is now Collier Engineering and we were in the middle of a contract with them. Rescinding that resolution due to the name change
- A transfer resolution for appropriation reserves

Mayor Watters asked about road money. Mrs. Mollineaux stated she was given road money to do Janes Chapel and Airport which are both grant projects and Mt. Bethel so that's what was funded. When the engineer said he was going to discuss some other road projects, she did send him an email that we were pretty much squared away with roads we were doing. She thought he was getting prices on milling and paving for what we were budgeting. She wasn't aware of the other roads being discussed. She cannot say if there is funding for those because the estimates the engineer had given her are obviously a few months old now and they could have been estimates as if going out to bid as opposed to Co-Op paving, but she cannot confirm that. She cannot say at this point if there is money for other roads because while we increased the road budget, we increased it by over \$400,000.00 to focus on these roads. It wasn't her understanding that we were going to do anything else. If it is the pleasure of the Committee to do more, we would fund more and have to use more surplus, but that's the decision the Committee has to make.

Mayor Watters suggested Mr. Snyder and Mr. Kastrud get together with Mrs. Mollineaux so they can get it figured out as soon as possible. Mrs. Mollineaux stated she can do a conference call with them. Based on the list that Mr. Snyder had read, Mrs. Mollineaux asked if there were other roads that were the Committee's intention to also do this year. Mayor Watters stated Mt. Bethel, Janes Chapel and Airport were the main concerned. If there is extra money after we do them, then we could possibly do those other roads. Mayor Watters asked if the conference call could happen tomorrow; Mrs. Mollineaux said she'd try to make that happen.

EMPLOYEES' REPORTS

Mrs. Fascenelli asked the Committee if the shredding event times could be changed from 9 - 12 to 8 - 11 allowing the shredding company to be able to do another job in the afternoon. Committee agreed to the change.

2018 Recycling Tonnage Grant – The Committee has a memo regarding the tonnage grant. We received a letter today that Mansfield is the second highest payout of 2018. Phillipsburg was first, Mansfield, Hackettstown, and Alpha. Mrs. Mollineaux stated the checks came today, so they will be included on both sides of the budget.

Green Team

<u>Earth Day</u> – The Team prepared a resolution for Earth Day. The Clerk suggested, and the Green Team agreed, to pull a couple of items and put them on the Township website and emails from companies that are composting. Rutgers does a lot with composting where people can get a lot of ideas. We will have to come up with a disclaimer saying there are more things out there, but this is what we have available.

<u>Drinking Water Tests</u> – The Team also received a letter that the Township received about the contamination of drinking water. It is part of Sustainable Jersey, so the Green Team did follow up. We have two companies that provide test kits that we are getting prices from. The one company that we did speak to will bring a van to wherever the Township wants, either this parking lot or at the public works. Residents go right to the van, pick up whichever test kit they want, take it home, do whatever is needed for the test, and another day the van is back again and they bring it right to the van. Township employees do not touch any money or samples. This is one avenue that we're looking at. Supposedly, according to the company, it is at a discounted price and we're hoping to get more people at one location. The Township would just advertise

what we are doing. That won't be until the fall, and Mrs. Fascenelli is waiting to get a price from another firm.

Landscape Design Competition – Last year we discussed with the Committee about landscaping in front of the Municipal Building. It would be sustainable per Sustainable Jersey and it should be drought resistant, making sure to include run-off. We are coming up with a letter for local landscapers and then we're thinking of applying for a Sustainable Jersey grant either in August 2021 or next year to offset the cost of having the work done and buying the plants. The grants are several levels - \$2,000, \$10,000 and \$20,000.

AN ORDINANCE AMENDING CHAPTER 281 OF THE TOWNSHIP'S GENERAL ORDINANCES TOWNSHIP'S PROHIBITIONS ON SMOKING TO INCLUDE PROHIBITING SMOKING ON PUBLIC PROPERTY

WHEREAS, the Township Committee of the Township of Mansfield finds that as determined by the New Jersey Legislature, smoking is one of the leading causes of preventable disease and death in the United States. In addition to the deleterious effects upon smokers, tobacco smoke is a substantial health hazard to the public, and an annoyance and a nuisance to the nonsmoking public. Tobacco smoke also creates a substantial health hazard to residents of the Township of Mansfield who may be participating in activities or events on public property; and

WHEREAS, while it is not the public policy of the Township to deny anyone the right to smoke, a balance must be struck between the right of smokers to smoke and the right of nonsmokers to breathe clean air. The Township Committee finds that on public property, the right of nonsmokers to breathe clean air outweighs the right of smokers to smoke; and

WHEREAS, this prohibition is consistent N.J.S.A. 40:48-1, 40:48-2 and 2C:33-13, which provide that smoking may be prohibited by municipal ordinance in any public place and the New Jersey Smoke-Free Air Act, N.J.S.A. 26:3D-55 et seq., which permits municipal ordinances to impose greater prohibitions against smoking than those provided under the Act, and N.J.S.A. 40:48-1, 40:48-2 and 2C:33-13, which provide that smoking may be prohibited by municipal ordinance in any public place; and

WHEREAS, the Township Committee recognizes the well-known health and safety risks posed by smoking and finds that it is within the public interest to prohibit smoking on public property, such as recreation areas; and

WHEREAS, the Township Committee has determined that the public interest is especially implicated in preventing the youth of Mansfield Township from being exposed and succumbing to the temptations of experimenting with tobacco products; and

WHEREAS, the Township Committee also finds that the appearance of the recreation areas can be enhanced and the limited resources of the Township's Department of Public Works can be conserved if smoking were to be controlled in such areas, thereby keeping such areas free of the litter generated by the smoking of cigarettes, such as cigarette butts, ashes and packaging.

WHEREAS, smoking is defined as the burning of, inhaling from, exhaling the smoke from or the possession of a lighted cigar, cigarette, pipe, vaping devices, or any other matter or substance which contains tobacco or any matter that can be smoked, or the inhaling or exhaling of smoke

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Mansfield that Chapter 281 of the Township of Mansfield General Ordinances be amended to include the following section:

Section 281-2 SMOKING PROHIBITION ON PUBLIC PROPERTY

Smoking shall be prohibited in all public recreation facilities owned or leased by the Township of Mansfield and all property owned or leased by the Township of Mansfield upon which the public is invited or upon which the public is permitted and where individuals gather for recreational activities.

Section 2

All other ordinance provisions which are inconsistent with the terms of this Ordinance, are hereby

declared null and void and repealed.

<u>Solar Stone Correspondence</u> – Mr. Hayes stated in the packet there is something from Solar Stone for 20 acres of historic fill. He asked where it is located in town – is it scattered or just one parcel. Ms. Hrebenak stated that this was the contact that was made and if we were interested, we could reach out to the company, but there are very few parcels that the Township owns that could be used for this.

<u>Mt. Bethel Church</u> – Ms. Hrebenak reported the engineer did go out to the church with the Civil Engineer and they will be putting the plans together.
