FINANCE REPORT

Mrs. Mollineaux reported:

<u>Best Practice Inventory</u> – is in the packet that we are required to fill out every year. Some information is fill-in, some have scores. We need to score a certain amount for us to receive State aid by the end of the year which we did and are in good shape.

<u>Corrective Action Plan</u> – the listed items in the audit that were a concern or recommendation from the auditor and the corrective action that needs to be taken. We had gone over it at the last meeting so there is a resolution that has to be done.

Executive Session – two personnel items and one contractual.

EMPLOYEES' REPORTS

Mrs. Fascenelli reported:

Neighborhood Sun – information in packet about New Jersey Community Solar Program in regards to the solar fields at the Blue Army Shrine. The representative is asking permission for the Township to advertise this type of shared solar energy. She is willing to do a presentation at the next meeting if the Township wishes to hear more about this type of shared service energy. They are looking for us to put something on the Township Website if the Committee approves to do something in the next newsletter just to get the word out to Mansfield Township residents about this community solar program. Mrs. Fascenelli will ask her to come to the next meeting to do a brief presentation.

Mr. Snyder reported:

Advertising – permission requested to advertise for part-time snow plow operators, preferably with CDLs, and two (2) full-time employees. He stated they are shorthanded and need the extra help to

get all the work done. He has two men in class three days a week. Deputy Mayor Mora Dillion suggested one (1) full time and one (1) part time. He agreed.

<u>Truck 11</u> – is the new International that's at Buck's County International for two (2) months waiting for a cam gear that is on back order.

<u>Truck 8</u> – won't start, might be a bad wire. Scheduled to go to Cory's next week to get the engine brake fixed.

Garage Roof - leaking, need to find a metal roofer

<u>Boiler</u> – Municipal Building, problem with the sound of banging on the pipes yesterday. Boiler was steam bound due to low water. Stryker Plumbing was able to get the water where it was supposed to be and it worked fine, but when Mr. Snyder checked on it today, it's off and the pipes are all cold. He's waiting for Stryker to call back tomorrow morning. Mr. Snyder will keep Mrs. Mollineaux posted about the repair.

Flooding – quite a few problems of flooding during the storm. Michael Road - Some caused by nature, some are man-made. A man-made problem was on Michael Road, on Hilltop the old DiRisio Farm #25 has a pond and when it rains, the owner dumps the pond that floods downhill to #30, 24 and 18 Michael Road. The one closest to Washington comes out his driveway and the whole road is covered with a foot of mud, dirt and stones. Something needs to be done where he's told he can't dump his pond or these people have to cut ditches and run the water off their property into his fields. By law, the DPW is not allowed on private property to put ditches in there to run the water. Deputy Mayor Mora Dillon asked if he has spoken to the man. Mr. Snyder spoke to a man on Michael, but has not met the person who owns DiRisio's. He requested a letter be sent to the property owner about the property and road damage and that he will be responsible for the road if major excavation is needed. The man on Michael Road who Mr. Snyder spoke to has placed across the road, on the edge of the road and in the road, equipment, Army trucks, a large boat that makes it hard for the DPW to get in and out of there with the big trucks. Mr. Snyder is not sure about the amount of right-away there. Deputy Mayor Mora Dillon suggested sending an email to our engineer. Airport Road – by the railroad tracks, the farmer put in a berm with dirt all along the tracks. Mr. Snyder put a berm in along the road and dug a ditch to funnel the water but there was so much water coming from the tracks on both sides it washed out where they put the new train signal in and the signal was teetering. He called the railroad that came and fixed it. The water came across the tracks by the road from the other side under the tracks and washed out the berm we put in with so much water it went down the ditch but a lot went on the road with pieces of ty and stone and all kinds of debris. Mr. Snyder brought a machine there to dump a large pile of dirt by the signal and got the water to go behind it and busted a hole in the back so it went down our ditch into the field. The water was so deep, the rail was far under water down 50 feet. Something needs to be done. The berm that the owner put in is damaging property and as of now it's damaging the railroad and our road which is a new road. Deputy Mayor Mora Dillon stated that Mr. Snyder email our engineer about the problem.

<u>Municipal Building Cleaning</u> – Deputy Mayor Mora Dillion asked if the DPW was still cleaning the municipal building. Mr. Snyder stated it was, but this week it was only once due to the storms. It will be cleaned twice a week.

PUBLIC PORTION

Deputy Mayor Mora Dillon opened the Public Portion of the meeting for comments.

Sara and Kyle Raft, 24 Michael Road, spoke about the flooding issue caused by the pond dumping from the DiRizzio property. Mr. Lavery will speak to the engineer about the problem.

Deputy Mayor Mora Dillon asked for further comment from the public; seeing none, the public portion was closed.

AN ORDINANCE OF THE TOWNSHIP OF MANSFIELD, COUNTY OF WARREN, STATE OF NEW JERSEY, AUTHORIZING THE SALE OF CERTAIN PROPERTY OWNED BY THE TOWNSHIP AND NOT REQUIRED FOR PUBLIC PURPOSES, PURSUANT TO N.J.SA. 40A:12-13(b)(1).

WHEREAS, the Local Lands and Buildings Law, N.J.S.A. 40A:12-13(b)(1) authorizes the sale by municipalities of any real property, capital improvements or personal property or interests therein, not needed for public use by private sale to any political subdivision, agency, department, commission, board or body corporate and politic of the State of New Jersey; and

WHEREAS, the Township of Mansfield is the owner of a 2017 Ford Explorer not needed for public use and the Township Committee has determined that it is in the best interest of the Township to sell the property for a nominal sum because the property is no longer useful to the Township; and

WHEREAS, Mansfield Fire Company has expressed an interest to the Township of Mansfield, of purchasing the 2017 Ford Explorer for a nominal sum; and

WHEREAS, there is a decided benefit to the taxpayers of the Township of Mansfield, for the 2017 Ford Explorer to be transferred to Mansfield Township Fire Company for its use.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MANSFIELD, COUNTY OF WARREN, STATE OF NEW JERSEY, as follows:

Section 1

The Township's 2017 Ford Explorer shall be sold at private sale to Mansfield Township Fire Company for nominal consideration pursuant to N.J.S.A. 40A:12-13(b)(1). The Mayor and Township Administration are hereby authorized to finalize and execute the attached Vehicle Sales Agreement and take such other reasonable steps that may be necessary to implement this sale.

Section 2

This ordinance shall take effect immediately after passage.

Section 3

Any ordinance that is inconsistent with the foregoing shall be deemed repealed by this ordinance.
