MANSFIELD TOWNSHIP LAND USE BOARD NOVEMBER 19, 2018 MINUTES

Some discussion occurred as to the Zoning Officer or Board's ability to put in writing exactly the verbiage from the proposed Buyer's letter.

Mr. Creedon had a concern that junkyard sales will be in front of the gate along the flat piece of the property along Route 57 by the billboard.

Several Board members felt that by Mr. Kastrud should reference our junk yard ordinance and state all local and State licenses must be obtained noting that there is nothing changing in the Mansfield Township Master Plan related to this.
