## MANSFIELD TOWNSHIP COMMITTEE MEETING

## February 13, 2008

This is a regular meeting of the Mansfield Township Committee. The notice requirements of the law have been satisfied for this meeting by notice to the Star-Gazette and the Express Times of the time, date and location thereof. Notice was also posted on the announcement board located in the Municipal Building.

Roll Call: Mrs. Oakley, Mr. Watters, Mr. Baldwin, Mr. Jewell, Mayor Nerbak

Salute to the flag was done by all.

Mr. Baldwin stated that he asked Mr. Layton to come in and speak to the Township Committee about third round COAH and the new regulations.

Mr. Baldwin asked if Mr. Layton felt that a letter from our attorney stating that we had submitted our plan on time with the rules that were struck down would that help the township.

Mr. Layton stated that even with the letter we would possibly still have to comply with the new rules.

# **COAH DISCUSSION:**

Mr. Joseph Layton, Planner for the Township of Mansfield spoke to the Township Committee about the new requirements for COAH's third round and how the plan that we had presented to COAH on October 6, 2006 may need to be amended to include the new requirements.

Mr. Layton stated that the new purposed third round rules include new affordable unit ratios for both residential and employment growth one affordable unit among five residential units and one affordable unit for every sixteen jobs generated is now the calculation used to determine the growth share for municipalities. The previous ratios were one affordable unit for every eight residential market units and one affordable unit for every twenty five jobs created.

Mr. Layton stated that if the group homes and the ministry camp count toward our affordable housing then we would be in good shape.

COAH has also reevaluated the rehabilitation share and prior round obligation (1987-1999) and updated those numbers for each municipality. There are a number of ways in which the compliance options have changed. In Mansfield's case this did not make a large difference.

Mr. Layton stated that under the third round rules based on the construction data Mansfield's Obligations through 2007 would be 22.2 which could be wither new building but may also include rehabilitation of existing buildings.

Mr. Layton pointed out to the Township Committee that key factors to meet the new Third Round Rules for Mansfield are at least 15 rental units, of this number at least 50% or 8 units must be

family rentals available to the general public the balance of the 15 units can be bedrooms in group homes.

Mr. Baldwin asked Mr. Layton about the age restricted housing development that has been approved and these rules were not in affect, and he is concerned that with the number of houses that are being built will drastically increase Mansfield's requirements.

Mr. Layton suggested that we speak to the developers and try to get them to comply with the new rules.

Mr. Layton went over the different options that could be done to comply with the rules as they are approved at this time.

Mr. Layton also explained that the township could possibly be ok at this time with what we have, but the township will have to apply to COAH and see what they accept.

The Firehouses will also be attending the Fire Academy on April 26 for the FIT 5 ARA demonstration and Mr. Jewell is planning on attending.

Mr. Baldwin stated that there was a letter of resignation received from the Animal Control Officers on Friday and that we are right now working with temporary animal control and that we will hopefully be able to appoint a new Animal Control Officer by the next meeting.

Mayor Nerbak stated that some of the Township Committee members attended Tri County Firehouses Chief's Dinner and that the Township Committee was presented with a plaque to thank the Township for their support. Mayor Nerbak thanked Tri County for their recognition of the help that the township has given them and also thanked all of the volunteers for all of their help and support throughout all of there years of service to the township.

Mayor Nerbak stated that there was correspondence received from the Musconetcong Rivershed and that they are requesting that the Township appoint someone to represent the Township. Mayor Nerbak stated that someone from the Environmental Commission would be a good representative.

Mr. Jewell stated that he would speak to the Environmental Commission at the meeting the next night.

Mayor Nerbak also stated that the Pohatcong Watershed would be having a meeting about stormwater and the Pohatcong at Warren County College and it would be good if someone could go as a representative of the Township.
