# A RESOLUTION PROVIDING FOR A MEETING NOT OPEN TO THE PUBLIC IN ACCORDANCE WITH THE PROVISIONS OF THE NEW JERSEY OPEN PUBLIC MEETINGS ACT, N.J.S.A. 10:4-12.

### First Reading

# 2010-11 CALENDAR YEAR 2010 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of Mansfield in the County of Warren finds it advisable and necessary to increase its CY 2010 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee hereby determines that a 1.0 % increase in the budget for said year, amounting to \$41,241.47 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Township Committee hereby determines that any amount authorized herein above that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Mansfield, in the County of Warren, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2010 budget year, the final appropriations of the Township of Mansfield shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5 %, amounting to \$ 144,345.17 and that the CY 2007 municipal budget for the Township of Mansfield be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized herein above that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

# ORDINANCE 2010-12

# AN ORDINANCE TO AMEND CHAPTER III A OF THE CODE OF THE TOWNSHIP OF MANSFIELD BY ADDING NEW SECTIONS 3 CLINIC SPORTS REGISTRATION FEES AND SCHOLARSHIPS

WHEREAS, the Township Committee of the Township of Mansfield has determined that there should be, within the Township of Mansfield; recreation registration fees.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Mansfield, County of Warren, State of New Jersey, that the Code of the Township of Mansfield is hereby amended to include the following provisions regarding recreation registration fees.

### Section 1

Chapter IIIA of the Code of the Township of Mansfield is hereby amended to include a new section establishing Clinic Sports Registration Fees:

Chapter IIIA-13. Clinic sports registration fees for participation of children in sports clinics of the Township of Mansfield shall be as follows:

- (a) Summer Field Hockey
  - i. \$40 for all players
- (b) Summer Junior Tennis Program
  - i. Pee Wee (ages 5-7) \$15 per week, per child
  - ii. Beginner (ages 8-10) \$25 per week, per child
  - iii. \$10 Insurance fee (paid one time, per child, per summer)

#### Section 2

This ordinance shall take effect immediately after passage.

#### Section 3

Any ordinance that is inconsistent with the foregoing shall be deemed repealed by this ordinance.

### RESOLUTION 2010-63

# A RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MANSFIELD, COUNTY OF WARREN, STATE OF NEW JERSEY, RATIFYING A ONE YEAR MEMORANDUM OF AGREEMENT WITH TEAMSTERS LOCAL 469

WHEREAS, the Township of Mansfield faces a significant fiscal crisis due to the extended economic downturn and the recent dramatic reduction in state aid; and

WHEREAS, the Township has sought alternatives to layoffs from the Township bargaining units and will be implementing many cost savings measures; and

WHEREAS, the Township negotiating team has reached agreement with Teamsters Local 469, bargaining representative for the Township's DPW workforce, to extend the union agreement through December 31, 2010; and

WHEREAS, said one year agreement includes substantial concessions that will allow the Township retain a DPW worker previously designated for possible layoff;

WHEREAS, the agreement includes the following:

- (a) A 0.0% salary increase for 2010, which follows a 0.0% increase for 2009;
- (b) Acceptance of the mandatory 1.5% of base pay contribution toward medical benefits.
- (c) Increase in doctor office visit co-pay from \$10 to \$20 and emergency room visit co-pay from \$25 to \$100.
- (d) Surrender of paid overtime from the date of ratification of the agreement by both parties through December 31, 2010, to be replaced with compensatory time off.
- (e) Suspension of the clothing and boot allowance through December 31, 2010.
- (f) The planned layoff of one (1) DPW worker shall be rescinded and no layoff of DPW workers shall be implemented through December 31, 2010.

NOW, THERFORE, BE IT RESOLVED by the Township Committee of the Township of Mansfield, in the County of Warren, State of New Jersey, as follows:

1. The Township Committee has concluded that the attached May 25, 2010 Memorandum of Agreement is in the interests of the Township of Mansfield and hereby ratifies the Memorandum of Agreement for immediate implementation upon ratification by Teamsters Local 469.

2. The Township Committee further authorizes the Mayor, Clerk and Township Labor Council to execute any additional documentation necessary to formalize this agreement.

Ms. Nerbak stated that the park committee met and they are coming up with some ideas for the park that would not cost the township any money.

Mr. Baldwin stated that there was a letter received about the Highlands and they are requesting a response back from the township.

Mr. Baldwin stated that he has been working on the shared service court.

Mr. Coppola stated that a new proposal was received from Washington Boro and their attorneys reviewed it and Mr. Vex is reviewing it right now.

Mr. Watters asked what the time frame would be for it to take place.

Mr. Baldwin stated that it would be about 2 months if the Shared Court proposal is approved to get up and running.

Mr. Jewell stated that he attended the Environmental Commission and there was discussion about the green team and recycling. Mr. Jewell stated that the Recycling Coordinator has been working on having a dumpster that all of the recycling can be put in.

Mr. Baldwin asked what the cost would be for the dumpster.

Mrs. Fascenelli stated that there is no cost for the dumpster.

Mr. Jewell asked Mrs. Fascenelli what size the dumpster was and if there will be rails placed underneath the dumpster so that there is no indentation caused on the parking lot.

Mr. Baldwin proposed that the dumpster be placed on the grass area so that there is no wear and tear on the parking lot.

Mr. Baldwin made a motion to move forward with the recycling dumpster at the municipal building, which was seconded by Mr. Watters.

Chief Ort asked about whether the police department would be able to purchase the Tahoe is this something that would need to wait until the budget is passed because the 2003 Durango is costing to much money to be fixed and needs to be taken off the road.

Mr. Watters stated that he would need to wait for the budget to be adopted.

Chief Ort also stated that the Traffic Supervisor asked if the township was interested in making some money why didn't we explore the option of an impound lot for the township instead of having all of the money going out to the towing yards. Washington Township makes a decent amount of money from their impound yard.

Mr. Watters suggested that we hook up with Washington Twp.

Mr. Kobert agreed that we should explore the option of a Shared Service with Washington Township in the mean time.

Mr. Baldwin motion to adjourn at 8:47, which was carried by all.
